(Competition intended for individual participation for pigeon fanciers with pigeons registered in the FCI Grand Prix of Portugal, European Championship and European Youth Championship).

Speed Race

(Competition intended for the individual participation for pigeon fanciers registered in Federations belonging to the FCI)

• European Championship

(Competition intended for national teams representing countries that are part of the FCI).

• European Youth Championship

(Competition intended for national teams representing countries that are part of the FCI).

2. What is the pigeon reception time?

• The pigeons should be sent between 1 April and 15 May 2015.

3. How old should the pigeons be at the time of delivery?

• At the time of delivery, the pigeons should not be less than 30 days and not exceed 45 days of age.

4. Should the pigeons be vaccinated beforehand?

• The pigeons should be vaccinated against Paramyxovirosis (Newcastle disease) 10 to 15 days before delivery. When sending please specify the date of vaccination and the vaccine used.

5. How to send the pigeons from overseas?

• If you intend to send the pigeons by plane, please follow these steps:

a)Send, by fax or e-mail, the AIR WAYBILL(AWB), list with identification of all the pigeons, a copy of the health certificates and an invoice with the notation "No Commercial value" and a declaration of donation to the Portuguese Pigeon Fanciers Federation. / **Note:** Send the original documents with the cargo (pigeons)

b)Send the pigeons to the following destination:

3.2 Ace Pigeon Ranking

- Two rankings will be used for the ace pigeon.
- The first ranking will be established by the sum of the averages of the official practices (over 100 km) + final competition;
- The second according to the points system.

Points will be awarded using the following criteria:

- All official practices (over 100 km) and the final competition will be counted;
- The point system remains fixed throughout every practice counting towards ace pigeon and the final competition;
- The number of points to assign to the first finisher is obtained by calculating 25% of the initially enrolled pigeons;
- 25% of the pigeons basketed in each practice (over 100 km) and final competition will be calculated for the corresponding awarding of points;
- The pigeon that totals the most points in the end is the winner;
- The provisional rankings for ace pigeon will be disclosed after each practice;
- To win the ace pigeon, the pigeon must rank in the final competition;
- In case of a tie, the pigeon that obtained the best classification in the final competition prevails;
- In the final test, the observation period ends when 25% of the pigeons have arrived or at 20.00 on the day following the release of the pigeons.
